



PAS 1192-7

Mr Surin, convenor of our Digitalisation and BIM Task Group has joined the British Standards Institute (BSI) committee in charge of drafting PAS 1192-7. This Publicly Available Specifications provide manufacturers and others with a plain language approach to providing and asking for information on products.

The current programme is to publish the full PAS during the second quarter of 2018, but two drafts will be released prior to the final version. [Read more...](#)

EC Technical Platform CPR

The European Commission will host the fifth meeting of the CPR Technical platforms, focussing this time on "Future of EOTA in the context of the CPR review".

The event will take place the 4th October 2017. The inputs collected during the meeting will be taken into account for a potential revision of the CPR.

OJEU publications

On 9th June the [updated list of EAD](#) was published in the Official Journal. EAD are available in the [website of EOTA](#). On 11th August the [updated list of hEN](#) was published in the Official Journal. It contains errors for the references to ENs 998-1:2016 and 998-2:2016. The date of applicability is given as 31/08/2018 and should be 11/08/2018 and the end of the co-existence period is not included and should be 11/08/2018. The next publication will contain the right dates.

On 8th July the following delegated acts were published: [Delegated act for the classification without testing for glued laminated timber products covered by EN 14080, structural finger jointed solid timber products covered by EN 15497](#) and [Delegated act for the classification without testing for external renders and internal plasters based on organic binders covered by EN 15824 and rendering and plastering mortars covered by EN 998-1 with regard to their reaction to fire](#)

On 17th August the [Delegated act for the classification of frost resistance performance for clay tiles under EN 1304](#) was also published.
