CETA for construction products

Following a request from our Secretariat, the EC has clarified how construction products are affected by CETA, the new trade agreement between the EU and Canada. As a summary, the products placed in the European market must follow the Construction Products Regulation (CPR) provisions and the same applies for product placed in the Canadian market for their regulatory provisions. For the moment, there are no notified bodies in Canada for the CPR nor European bodies able to certify Canadian requirements. Read more...

compliance will mean heavy fines.

Arguably the biggest change is the extended jurisdiction of the GDPR, as it applies to all legal entities processing personal data, regardless of location. More so, the conditions for consent have been strengthened. Read more...
